

The Grand Jurors of Yavapai County, Arizona, accuse THOMAS JONATHAN CHANTRY, charging that in Prescott Precinct, Yavapai County, State of Arizona:

COUNT 1
AGGRAVATED ASSAULT

THOMAS JONATHAN CHANTRY, on or between January 1, 1998 and October 31, 2000, being eighteen years of age or more, knowingly did touch [REDACTED], a child of 15 years of age or under, with the intent to injure, insult or provoke to wit: hitting [REDACTED] with a boat oar in 5th grade, in violation of A.R.S. §§ 13-1203, 13-1203, 13-701, 13-702, 13-702.01, and 13-801, a class 6 Felony.

The State further alleges that the offense charged in this count is an offense that was committed with a sexual motivation, in violation of A.R.S. §§ 13-118 and 13-3821.

1 13-3821, 31-281, 13-604.01, 13-705 13-702, 13-702.01, and 13-801, a class 2 Felony.

2 The State further alleges that the offense charged in this count is a Dangerous Crime
3 Against Children in violation of A.R.S. §13-705.

10 [REDACTED] with a hand in the trailer, in violation of A.R.S. §§ 13-1203, 13-1203, 13-701, 13-702,
11 13-702.01, and 13-801, a class 6 Felony.

12 The State further alleges that the offense charged in this count is an offense that was
13 committed with a sexual motivation, in violation of A.R.S. §§ 13-118 and 13-3821.

16 **COUNT 6**
17 **MOLESTATION OF A CHILD**

18 THOMAS JONATHAN CHANTRY, on or between January 1, 1998 and October
19 31, 2000, intentionally or knowingly did molest [REDACTED] a child under the age of
20 fifteen years, by engaging in sexual contact with [REDACTED], a child under fifteen years of
21 age, to wit: fondling [REDACTED] in the trailer, in violation of A.R.S. §§ 13-1401, 13-
22 1410(A), 13-3821, 31-281, 13-604.01, 13-705 13-702, 13-702.01, and 13-801, a class 2
23 Felony.

24 The State further alleges that the offense charged in this count is a Dangerous Crime
25 Against Children in violation of A.R.S. §13-705.

1 31, 2000, being eighteen years of age or more, intentionally, knowingly or recklessly did
2 cause physical injury to [REDACTED] a child of 15 years of age or under, to wit: hitting
3 [REDACTED] with a boat oar, incident in September 2000, when [REDACTED] mother observed
4 bruising after picking [REDACTED] up from tutoring, in violation of A.R.S. §§ 13-1203, 13-1203,
5 13-701, 13-702, 13-702.01, and 13-801, a class 6 Felony.

6 The State further alleges that the offense charged in this count is an offense that was
7 committed with a sexual motivation, in violation of A.R.S. §§ 13-118 and 13-3821.
