Thank you for your interest in the 2019 Pintail Slough Junior Waterfowl Camp. This camp is designed to give juniors the opportunity to experience a full waterfowl hunt, including: practicing safe shotgun use, learning waterfowl hunting laws, identifying and hunting waterfowl, field dressing and preparing waterfowl meat, and sharing stories from the hunt with friends around a warm evening campfire. The aspiration of this program is to inspire juniors and their friends and families to spend more time recreating outdoors, and to foster within them an appreciation of wildlife, nature, and our hunting and fishing heritage.

There will be great emphasis on hunter safety, especially relating to firearm use. As you register, please keep in mind that the camp begins with a **mandatory** shotgun use and hunter safety clinic beginning at 2:00 PM Friday, January 4, 2019. At this clinic, it is important that you and the instructors make sure that your junior hunter is equipped with an appropriately sized shotgun, and can safely handle and shoot the firearm. If the shotgun instructors feel that any junior cannot safely take part in the hunt, that junior will not be able to participate. I thank you all for helping us to keep the safety of all those involved in this weekend a priority. During the camp no firearms are to be handled without a camp instructor or mentor present.

The juniors will be the only individuals allowed to hunt waterfowl; however the other camp activities are open to all members of the family. Join your junior hunter in a lesson about waterfowl identification, or a clinic on field dressing and preparing waterfowl meat. Friends and family members are encouraged to enjoy the last weekend of the mourning dove season, try their hand at bagging Eurasian doves or Gambel's quail, or go on a hunt for those sneaky cottontails and wily coyotes (see <a href="http://www.azgfd.gov/h">http://www.azgfd.gov/h</a> f/hunting units 15d.shtml for information on where to hunt in GMU 15D). There are also numerous great fishing opportunities nearby, which provide fun for all ages. This truly is a weekend of outdoor enjoyment for the entire family. I hope that by the time the camp wraps-up Sunday afternoon, everyone who came will have many new friends, memories, and stories to share back at home.

# HOW TO REGISTER: Please Read!

Please complete all three attached registration forms. A separate registration packet must be submitted for each junior hunter you wish to register. A complete registration packet consists of one registration form, two liability waivers (one for minor, one for adult), and a check for the \$40 refundable registration fee.

All checks must be made out to Wildlife for Tomorrow.

You may also drop off your registration paperwork in person at the Kingman AZGFD office during normal business hours.

Your check(s) will not be cashed unless you do not show up the weekend of the hunt. When you show up and sign in that weekend, your check will be handed back to you. You may cancel without penalty until December 18, 2018.

Applicants will be chosen through a lottery system on December 22, 2018. Beginner junior hunters will have priority in the lottery. Selected applicants will be contacted December 22-31 to confirm attendance.

If you wish to check on the status of your registration paperwork, please call the Kingman AZGFD office at (928) 692-7700.

Each registration packet must be complete, including a \$40 check made out to Wildlife for Tomorrow, to secure a spot in our junior hunter lottery.

Completed registration packets must be received by the Kingman AZGFD office by close of business on Friday, December 21, 2018. Postmarks will not be accepted, and late registration packets will not be considered.

Please use this form to register for the Junior Waterfowl Camp to be held Friday, January 4 – Sunday, January 6, 2019, at Havasu National Wildlife Refuge/Pintail Slough. You should register as an individual, but may indicate the name of an individual/group with whom you wish to hunt.

#### Please send a separate \$40 check, made out to Wildlife for Tomorrow, for each junior hunter.

The hunt is open to junior hunters ages 12-17. A properly licensed adult must accompany all junior hunters. One licensed adult can legally supervise not more than 2 junior hunters.

Registration will be done using a lottery system. There is a \$40 refundable registration fee. The registration fee will be refunded when the hunter checks in on-site January 4, 2019. If you need to cancel, you may do so without penalty prior to December 22, 2018. The hunt is limited to 18 hunters.

### Waiver and Release of Claims for Injury or Death 2019 Pintail Slough Junior Waterfowl Camp Minor

On behalf of the Minor, I hold harmless Arizona Game and Fish Department, U. S. Fish & Wildlife Service, Havasu National Wildlife Refuge, Arizona Outdoor Sports, and Ducks Unlimited, their directors, officers, shareholders, employees, and agents, without limitation, from any and all claims or liabilities from any claim by the Minor, the Minor's family, estate, heirs or assigns, arising out of or connected in any way with the Minor's participation in the Hunt, even though the liability may arise out of negligence or carelessness of the person or entities mentioned above.

The Minor's participation in the Hunt is voluntary and done at the Minor's own risk. I acknowledge and certify that I am cognizant of all the inherent dangers of the use of firearms and of the basic safety rules for activities associated with hunting. I understand that serious accidents occasionally occur during the use of firearms, and that persons using firearms occasionally sustain mortal or serious personal injuries and/or property damage as a consequence thereof. Knowing the risks of the use of firearms, I, on behalf of the Minor, nevertheless, personally and voluntarily assume all risk of loss, damage or injury that may be sustained by the Minor while participating in the Hunt, whether foreseen or unforeseen, and I release and hold harmless all of the persons and entities mentioned above who, through negligence or carelessness or otherwise, might be liable to the Minor or the Minor's heirs, personal representatives or assigns for damages.

I understand and agree that medical or other services rendered to the Minor by or at the insistence of the persons or entities mentioned above is not an admission of liability to provide or to continue to provide any such services, and is not a waiver by any of the persons or entities mentioned above or any right or rights in this Waiver and Release.

The Minor is physically and mentally fit and capable to use and handle firearms during the Hunt. I understand that it is not the function of the organizations sponsoring the Hunt, their employees, operators, or agents to serve as guardians of the Minor's safety. I also understand that if the Minor furnishes his or her own firearms and related equipment for their use that I am responsible for the safety and good operating condition of those firearms and related equipment regardless of where they are obtained.
