COVID-19 WAIVER AND RELEASE

This COVID-19 Waiver and Release MUST BE READ CAREFULLY AND SIGNED IN CONSIDERATION of the Undersigned's ability to attend the 2020 Prescott Frontier Days, Inc. (the "Organization") Rodeo and any related activities ("2020 Rodeo"). The World Health Organization has declared Coronavirus (COVID-19) to be a worldwide pandemic. Due to COVID-19's capacity to easily transmit from person-to-person through various means, there is a high risk of COVID-19 exposure to anyone attending the 2020 Rodeo.

Therefore, in consideration of the Undersigned's attendance at the 2020 Rodeo, the <u>Undersigned acknowledges and agrees to the following:</u>

- 1. <u>**REPRESENTATIONS:**</u> The Undersigned represents:
 - a) I have not experienced symptoms of fever, fatigue, difficulty in breathing, dry cough nor have I exhibited any other symptoms relating to COVID-19 within the last 30 days.
 - b) I have not been, nor has any member(s) of my household, been diagnosed to be infected with the COVID-19 virus within the last 30 days.
- 2. EXPRESS ASSUMPTION OF RISK: The Undersigned is aware of the existence of the risk by attending the Organization's 2020 Rodeo at the Organization's venue which may result in exposure to COVID-19, despite the Organization's reasonable efforts to mitigate the risk. By signing this release, the Undersigned acknowledges the extremely contagious nature of COVID-19 which may result in SERIOUS INJURY, ILLNESS, PERMANENT DISABILITY, PARALYSIS AND/OR DEATH. By being allowed to attend the 2020 Rodeo, the Undersigned voluntarily agrees to assume any and all risks and dangers of being exposed to and becoming infected with COVID-19 at the 2020 Rodeo.
- 3. <u>WAIVER AND RELEASE</u>: With full knowledge of the risks involved of being exposed to and becoming infected with COVID-19 at the 2020 Rodeo, the Undersigned hereby releases, waives, and forever discharges the Organization and the City of Prescott, their respective boards and council, officers, independent contractors, affiliates, employees, representatives, successors, and assigns from any and all liabilities, claims, demands, actions, and causes of action whatsoever, directly or indirectly arising out of or related to any LOSS, DAMAGE, INJURY, INCLUDING PARALYSIS OR DEATH, that may be sustained by the Undersigned related to COVID-19 while attending any affiliated activity at the Organization's 2020 Rodeo.
- 4. <u>INFORMED CONSENT AND VOLUNTARY ATTENDANCE</u>: The Undersigned fully acknowledges and understands that COVID-19 is highly contagious, and he/she has taken it upon himself or herself to be fully informed of the risks and potential danger associated with COVID-19. The Undersigned acknowledges that his/her attendance at the Organization's 2020 Rodeo is completely voluntary and done with full knowledge and assumption of any COVID-19 relate d risks.

By signing below, the Undersigned acknowledges that he/she has read the foregoing COVID-19 Release and understands its contents; that he/she is at least eighteen (18) years old and fully competent to give consent to this COVID-19 Release; that he/she has been sufficiently informed of the risks involved and hereby gives his/her voluntary consent in signing this COVID-19 Release as his/her own free act and deed with full intention to be bound by the same, and free from any inducement or representation; and, that if the terms hereof are unacceptable to the Undersigned, if the Undersigned has purchased one or more tickets for admission to the Organization's activities and events, that the Undersigned's purchase price will be fully refunded in a timely manner.

Furthermore, to the extent that any of those attending the 2020 Rodeo with the Undersigned are under the age of eighteen (18) years old, or otherwise not competent to sign this waiver and release, the Undersigned represents that he/she is authorized to sign this waiver and release on the child's or any other person's behalf who are identified as follows:
